The NRA began in 1871, founded on the principal that the 2nd Amendment is the true and fundamental guarantee of all individual rights. For over 131 years, the NRA has fought to safeguard that guarantee, continually exposing and defeating the compromises that would destroy it. Only if we act, in that same spirit, can our actions defend the rights we exercise today and maintain those same rights for our children, just as past NRA members did for us.

Today's NRA minutemen are organized into NRA Members' Councils.

NRA Members' Councils are NOT hunting or gun clubs. They are local groups of NRA members that coordinate NRA members' efforts to fight the "Politics of Gun Control".

NRA Members' Councils are not tied to any politician or political party, but rather are SINGLE ISSUE groups of volunteers dedicated to getting gun owners involved in protecting their rights. Members' Councils are not fund raising organizations, instead they focus NRA resources to bring the NRA's message of "Safety, Responsibility and Freedom" to the local community.

Projects and Activities of the NRA Members' Councils

- Promote membership in the NRA and California Rifle & Pistol Association (CRPA)
- Monitor local government bodies and agencies
- Provide NRA certified instructors for: Firearms safety and operation classes, Women's Issues, *Eddie Eagle*, Youth programs such as *4-H* and *Boy Scouts of America*
- Participate in community projects such as the *Toys-for-Tots* with the U. S. Marine Corps Reserve
- Voter Registration of firearms owners
- Participate in the election campaigns for pro-2nd Amendment candidates
- Write pro-2nd Amendment Letters to the Editor for our local newspapers
- Contact the legislature to support gun rights and to oppose gun prohibition
